

# 2022 DOG LICENSE FEES



In accordance with the fees established by the Lorain County Commissioners, Commissioner's Resolution #19-611, prices effective 12/01/2021, dog license registration fees for the 2022 tag year will increase to \$24 for Regular tags, \$29 for Special tags, \$76 for Three-year tags, and \$240 for Permanent (Lifetime) tags. For your convenience, online presale licenses begin November 1<sup>st</sup> at the 2022 tag year rate. ## **WORTH MENTIONING**

Homeowners are given the opportunity to file with the Board of Revision if they disagreed with their 2021 assessed value for their property. Once the Auditor's tax duplicate is certified; taxpayers may begin submitting complaints after January 1<sup>st</sup> through March 31<sup>st</sup>, 2022. The board will begin the hearing process of complaints for the 2021 tax year payable in 2022 afterwards. Due to state mandated rules, there was a triannual update to property values for 2021. This process was handled strictly through market analysis as opposed to a full reappraisal where each property is physically viewed.
