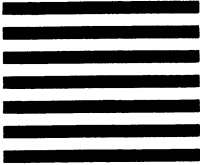

Carpool Ride-Matching

Don't have a carpool partner? We have a database with thousands of commuters from 14 counties who want to carpool. We can match you with someone who lives near you, works near your work place and works the same hours (maybe even someone who works for the same employer). Then you can call people on your list and make carpool arrangements that make sense for you. There's no commitment, no obligation and no cost.

Vanpooling Assistance

For groups of 11 to 15 people, we can also help organize vanpools. Vanpools can be a really economical way to commute, especially for groups traveling long distances. Through an arrangement with the Ohio Department of Transportation, we can even help arrange a van lease at a sensible cost that includes maintenance and insurance. Financial assistance is available to qualified vanpool groups, and there is no long-term commitment. Call us for more information

Guaranteed Ride Home

Concerned about being stuck at work in the event of accident, illness or emergency? The Guaranteed Ride Home program will reimburse you 80 percent of your bus fare, cab fare or even rental car fees, up to a \$60 maximum. This benefit is available to qualified car and van poolers up to four times a year.

Most people find that ride sharing offers the kind of savings, stress reduction and sense of safety that make it worthwhile.
