Zoning

Two permits were issued. A variance request has been received for 41511 Parsons Road. The ZBA will hold a public hearing on July 21. The health issues on a property on Indian Hollow Road will be investigated by the Lorain County Health Department and the EPA. The Moyses property will be turned over to the prosecutor.

Canfield asked about problems with swimming pools still having water in them when the house has been abandoned. The Zoning Inspector should be notified.

Brian Clark was in attendance to ask permission to construct a haunted forest on Parsons Road for Halloween. He would construct 10-15 small buildings which would be removed and collect canned goods and clothes as well as donations.
